At EUROFI's 2009 Forum, held in Göteborg, Sweden, from 29<sup>th</sup> September to 1<sup>st</sup> October 2009, over 100 speakers and 500 delegates will aim to clarify the main regulatory measures and the changes required in terms of supervision, at the same time highlighting the economic and operational impact of the measures for banks, insurance companies, payment and securities infrastructures and asset managers. The main legislative texts on the agenda of the Council and the European Parliament (AIFM, CRD...) will also be covered. Entitled "**What priorities for the incoming European authorities in light of the financial crisis ?**", this international symposium is taking place ahead of the **Eurogroup** and the informal **ECOFIN Council**.
